A charming Grade II Listed early Victorian cottage, quietly positioned within a private lane in the heart of Summertown. A beautiful home dating from 1800's, this very attractive cottage enjoys a particularly discreet setting off Summertown's vibrant shopping and restaurant parade, offering excellent access to amenities while remaining peacefully tucked away. The property has been sensitively restored during the 20th century and retains a number of period features throughout. Outside, the rear garden is laid primarily to lawn and benefits from pedestrian access, creating a pleasant and practical outdoor space. Residents' permit parking is available. The property also benefits from a residential parking permit. The property is ideally located for Summertown's excellent range of shops, cafés and restaurants, with Oxford city centre approximately 1.8 miles away and Oxford Parkway station about 2.1 miles distant.
